

PPF AND TINT WARRANTY INFORMATION

APEAX - hereby guarantees the owner that we offer a 10 Year Warranty on our Apeax Xtreme PPF Range and a Lifetime Warranty on our Apeax Xtreme Tint Range.

This limited warranty is applicable solely to the company's products when professionally installed according to the company recommendations.

If replacement is chosen, the company will engage an installer of its choice to remove and reapply the product to areas specified by the company under this limited warranty.

APEAX will cover the cost of replacement film for any defects covered under this limited warranty. The replacement of the defective film is the sole and exclusive remedy provided for all products under this warranty.

Throughout the warranty period, the company's obligation for repair or replacement is limited to the specific product affected by a manufacturing defect, using products available at the time of repair or replacement.

Any repaired or replaced product remains subject to the original warranty period, without extension or initiation of a new warranty period. These remedies are exclusive for all products under this limited warranty.

To use coverage under this limited warranty, you must provide the company with a proof of warranty email and a detailed description of the alleged defect with photographic/video evidence. You must have registered your warranty using our online form.



Apeax - Paint Protection Films serve as effective sacrificial layers, offering robust paint protection. This limited warranty does not cover defects caused by:

- Non-compliance with the company's guide or instructions, including exposure to physical or chemical abuse, thermal abuse or shock, and misuse;
- Improper storage, installation, handling, and/or use of the product;
- Damage not resulting from manufacturing defects during the customer's possession;
- Unreasonable or unintended use of the product;
- Products installed with known or visible manufacturing defects at the time of installation, including scratches, scuffs, scrapes, chips to the painted surface;
 - Damage due to improper wash techniques, automatic car washes, or incorrect wash tools by third parties not authorized by the company;
 - Scratches, scuffs, scrapes, chips to the painted surface;
 - Water spots not covered under this limited warranty;
 - Damage caused by collision, accidental damage, vandalism, fire, hail, flood, surface rust, rail dust, physical damage, paint overspray, or paint manufacturer' defects, which may be covered under a manufacturer's protection plan;
 - Damages caused by outside forces, including the physical impact of rocks or road debris.

No claim by the buyer/owner of any kind, including claims for indemnification, shall be greater in amount than the purchase price of the products in respect to which damages are claimed.




APEAX is proud to offer a Limited Lifetime Warranty on our premium automotive window films and tints. This warranty guarantees that our films are free from defects in materials and workmanship, providing you with peace of mind for the entire time you own your vehicle.

Coverage

The warranty covers the following:

- Adhesive Failure: Peeling, bubbling, or delamination.
- Discoloration: Noticeable fading or color change that compromises the film's aesthetic or performance.
- Cracking or Blistering: Physical degradation of the film's surface.
- Performance Degradation: Loss of heat rejection or UV-blocking properties.



This warranty does not cover the following:

- Improper installation or use of the film not adhering to Manufacturer's guidelines.
- Damage due to abuse, neglect, or accidents (e.g., scratches, chips, or abrasions).
- Defects caused by exposure to abrasive cleaners, improper maintenance, or misuse.
- Natural wear and tear, or damage caused by environmental factors such as extreme temperatures beyond standard vehicle conditions.

To qualify for a warranty claim:

- 1. The film must be installed by a Certified Installer authorized by the Manufacturer.
- 2. Proof of purchase and installation (including original invoice) must be provided.
- 3. Claims must be reported to the Manufacturer or the Certified Installer within 30 days of noticing the defect.





Annual inspections

To maintain the warranty on your product, an annual inspection is required throughout the warranty period, as stated in the product specifications. This inspection should be performed by a APEAX Installer every year. Failure to complete the inspection, within the required time will void the limited warranty.

Any fees or charges by the APEAX installer will be charged to the owner to do the annual inspection including, but not limited to, exterior wash, decontamination, and inspection.
